Item 1. Enter the name of the limited partnership exactly as it reads in records of the Secretary of State's Office.  
If the Limited Partnership has been administratively dissolved and the name is no longer available for use, the name must be amended on line #3a.

Item 2. Enter the date in which the organizational documents were filed with this office and the domestic state of the entity.

Item 3. Mark the appropriate boxes for the amendments that you wish to make.

Item 3a. Is used if the name of the limited partnership is being changed; indicate the new name on line 3a of the application. Make certain the new name of the limited partnership contains the requirements of Idaho Code § 53-2-108. It is advised that you contact the Secretary of State's Office to check the name for availability.

**NOTE:** If a foreign limited partnership is making a name change, the application must be accompanied by an original certificate from the proper filing officer in the jurisdiction under whose laws the limited partnership is organized, evidencing the name change. Please note that the certificate required is a one page document. A certified copy of the articles of amendment or merger is not acceptable.

Item 3b. Is used to withdraw a general partner; indicate the name of each general partner to withdraw.

Item 3c. Is used to add new general partner(s); indicate the name and address of each new general partner.

Item 3d. Check this box to make the statement that the limited liability limited partnership is deleted.

Item 3e. Indicate by checking in the box whether the limited partnership is or is not a limited liability limited partnership.

Item 3f. Is used if all general partners have withdrawn and the events of the limited partnership are being continued.

Item 3g. Is used if making an amendment not listed above.

Enclose the appropriate fee:

The filing fee is \$30.00

If expedited service is requested, add \$20.00 to the filing fee.

If the fees are to be paid from the filing party's pre-paid customer account, conspicuously indicate the customer account number in the cover letter or transmittal document.

Pursuant to Idaho Code § 67-910(6), the Secretary of State's Office may delete a business entity filing from our database if payment for the filing is not completed.
