**ORDER DIRECTING PARTICIPATION IN THE HIGH CONFLICT PARENTING GROUP**

On the Court's own motion, the Court having jurisdiction of the parties and the subject matter hereto;

**THE COURT FINDS:**

1. that the parties are a "High Conflict Couple" impacting on the best interests of the children and therefore in need of special counseling designed to improve communication and reduce the stress on the parties and their children;
2. that the "Putting Kids First" Program is designed to accomplish these ends.

**IT IS THEREFORE ORDERED THAT:**

- A. The parties will actively participate in and successfully complete the "Putting Kids First" Program at the PKF Group.
- B. Information Shared during sessions of the program is confidential and shall not be disclosed. PKF Group, staff and records concerning the sessions shall not be subject to subpoena.
- C. The parties shall not, without leave of Court, file any new pleadings or initiate any new litigation for the duration of the "Putting Kids First" Program, unless an "Emergency".
- D. The PKF Group shall report to the Court information about program attendance, level of participation and compliance to program rules.
- E. The parties will share the costs 50/50 subject to reallocation after the program is successfully completed.
- F. The parties shall call the PKF Group, 822 N. 129<sup>th</sup> Infantry Drive, Suite 103, Joliet, Illinois 60435, (815) 823-8460 within three (3) business days to schedule their intake interview.
- G. The parties shall comply with all rules for the "Putting Kids First" Program as established by the PKF Group.
