INSTRUCTIONS FOR MINOR CHILD(REN) NAME CHANGE HEARING

Try to arrive at the hearing at least 15 minutes before your hearing is scheduled. Once you arrive at the courtroom for the hearing, you should ask the Clerk of the District Court how to let the judge know you are there for the hearing to change your minor child(ren)'s name(s).

The court may ask to review your Decree(s) for Name Change of a Minor before the hearing, so have the Decree(s) prepared, along with one copy.

When the court calls your case, you will be asked if you are ready to proceed. You must tell the court that you are ready and would like to testify. You will be asked to take the stand and the judge will give you an oath to tell the truth. You are then ready to go forward with your case.
