INSTRUCTIONS FOR ADULT LEGAL NAME CHANGE

These sample forms have been assembled for your convenience in preparing your own legal name change. This package is only designed to cover a simple, uncontested name change. If you have questions about whether this package is suitable for your situation, *you may wish to contact an attorney*. Our employees are prohibited by law from advising you regarding your legal situation or whether this package is appropriate for your situation. This includes explaining the procedures or instructions.

North Carolina General Statutes Chapter 101 on name changes provides the following:

- A name change is effective ONLY to change the name on the Birth Certificate
- Petition must be filed in county where you live and proof of residence is required (driver's license, utility bill, etc)
- A person can only change his/her name ONE time under this chapter

THESE FORMS MUST BE EITHER TYPED OR NEATLY PRINTED IN BLACK INK. PETITION AFFIDAVITS MUST BE NOTARIZED PRIOR TO FILING AT THE CLERK OF COURT.

- 1. The "NOTICE" must be date-stamped in the Special Proceedings office on the 12th floor of the Wake County Courthouse and then posted on the courthouse bulletin board for at least ten (10) full calendar days. This board is located at the Salisbury Street entrance of the courthouse.
- 2. There will be a filing fee which must be paid in cash or certified funds. We do <u>not</u> accept personal checks, credit cards, or debit cards. There are ATM machines available on the 1st and 6th floor.
- 3. Furnish the original <u>or</u> certified copy of your Birth Certificate <u>and</u> a valid Picture Identification. If you have a foreign Birth Certificate that is not written in English, you may also use United States Citizenship papers or a valid Passport in lieu of a Birth Certificate.

Along with your Notarized Petition and two (2) affidavits of character, adults must also submit a list of counties/states lived in for the last 10 years and a criminal history record check from EVERY county/state in which you resided. A criminal background search for Wake County can be obtained in Room 118. Please note there is a charge for this search.

- 5. Once your forms have been reviewed in our office, you will be required to complete the Order and Certificate of Name Change in our office. Please allow extra time to complete this form.
- 6. If you were born in the State of Florida, please see the Clerk for more detailed information.

***** INSTRUCTIONS FOR MINOR LEGAL NAME CHANGE *****

7. To change the name of a child less than 16 years of age, we do not need "Affidavits of Character," a criminal background check, or the posting of the "Notice." If the child is 16 or 17, we do need the "Affidavits of Character". However, no criminal background check or "Notice" is required. One parent may not change the name of a child without the consent of the other parent, unless no father is listed on the child's Birth Certificate. Therefore, you must furnish a RECENT certified copy of the child's Birth Certificate. If the father is not on the Birth Certificate, the child must be 1 year old in order to complete the name change. Any other situation regarding consent of a parent is not considered a simple name change, and you may wish to consult with an attorney for further information.
