# FORMS & INSTRUCTIONS FOR CHANGE OF NAME (OF A MINOR) (ORS 33.410 TO 33.440 & UTCR 9.320 & SLR 8.155)

### CHANGING THE NAME OF A MINOR:

Changing the legal name of a minor can be a simple process if no one objects to the change. The following are the steps involved:

- (1) Being appointed Guardian Ad Litem for the minor
- (2) Posting a public notice of the proposed name change in the Courthouse for at least 30 days
- (3) Personally serving the "other parent" if involved
- (4) A brief appearance before a judge who will sign the name change decree
- (5) A public posting of the name change of the minor for the new name to become official

- (5) Affidavit of Posting Notice of Name Change Hearing (Form 5)
- (6) General Judgment of Name Change (Minor) (Form 6)
- (7) Notice of General Judgment of Name Change (Minor) (Form 7)
- (8) Affidavit of Posting Notice of General Judgment (Minor) (Form 8)
- (9) Affidavit Supporting Waiver of Written Notice to Other Parent RE: Name Change of a Minor (Form 9) **OPTIONAL**
- (10) Consent of Parent or Guardian for Name Change of a Minor (Form 10) **OPTIONAL**
- (11) Proof of Mailing RE: Petition & Notice of Name Change Hearing (Certified Mail) (Form 11) **OPTIONAL**

### **FEES**

The charge for the forms provided at the courthouse is \$1.25. The court filing fee for a name change is \$158.00. There is a \$5.00 charge for a certified copy of your general judgment of name change. There is also a \$10.00 judgment fee due and payable on the date of your hearing.

### **INSTRUCTIONS**

Please read all instructions carefully. <u>USE BLACK INK ONLY ON THE FORMS.</u> DO NOT FILL OUT ALL THE FORMS AT ONCE. YOU WILL NEED TO COMPLETE THE FORMS AS YOU COMPLETE THE STEPS FOR A NAME CHANGE. These are legal documents which must not contain mistakes. Do not alter the documents.

### (First Visit to Courthouse)

STEP 1:

- A. Fill out the Application for Appointment of Guardian Ad Litem for Name Change of a Minor (Form 1)
- B. Fill out Order for Appointment of Guardian Ad Litem for Name Change of a Minor (Form 2) Please type or print.

# STOP.....DO NOT FILL OUT ANYMORE FORMS AT THIS TIME. FOLLOW INSTRUCTIONS.

STEP 2:

- A. Sign Form 1 in front of Family Law Clerk, located in Room 211 of the Multnomah County Courthouse. (Make sure you bring **one** form of valid photo identification)
- B. Check with Family Law Clerk to determine which Judge is handling Ex Parte. Ex Parte is held Monday-Friday at 8:30AM and 1:30PM. You cannot file your case until you have been appointed your child's Guardian Ad Litem. Judges are available at 8:30AM and 1:30PM daily to hear your request, so plan your trip to the courthouse appropriately around these times.
- C. Present Form 1 & Form 2 to the Judge at Ex Parte time for his/her signature. The judge will give you back your paperwork and instruct you to return to Room 211 for further processing of your name change.

STEP 3:

A. Fill out the PETITION FOR NAME CHANGE OF A MINOR (Form 3) Please type or print.

# STOP.....DO NOT FILL OUT ANYMORE FORMS AT THIS TIME. FOLLOW INSTRUCTIONS.

- B. Sign Form 3 in front of the Family Law Clerk, located in Room 211 of the Multnomah County Courthouse. (Make sure you bring one form of photo identification) <u>Ask Family Law Clerk to make you one copy of Form 3.</u>
- C. Go to the cashier, located in Room 210 of the Multnomah County Courthouse. Pay the \$1.25 form fee and the \$158 court filing fee and \$5.00 copy fee. Obtain a case number from the cashier, making sure the cashier puts the case number on all eleven forms.

### (Continued Instructions on First Visit to Courthouse)

STEP 4:

- A. Complete NOTICE OF NAME CHANGE HEARING (Form 4) Leave the following spaces blank: hearing date & time of hearing
- B. Take Form 4 back to Room 211. Use the telephone on table by name change board and dial 83185. Ask for a Name Change hearing date for a **MINOR**.
- C. Fill in the hearing date on Form 4. Ask the Family Law Clerk to make you one copy of Form 4.
- D. Post Form 4 on the NAME CHANGE BULLETIN BOARD in Room 211. This form must remain posted for at least thirty full days prior to the hearing.

You now need to decide which method of service you will be using to serve the "other parent" or "legal guardian". Below are options you need to consider.

The "other parent" or "legal guardian" must receive a "true copy" of Form 3 & Form 4 and you must show "proof of service" to the court that the "other parent" or "legal guardian" received the copies.

#### Personal Service:

<u>You cannot</u> personally serve the "other parent" or "legal guardian". It must be someone over the age of 18, who is not a party to the suit, nor attorney or employee of yours. With the copies of Form 3 & Form 4 the Family Law Clerk has provided you, you may request the County Sheriff's office to personally serve the "other parent" or "legal guardian". If the "other parent" or "legal guardian" live in Multnomah County, our Sheriff can serve your papers. The fee for this is \$28.00 and you can pay the cashier in Room 210 and the cashier will forward your papers to the sheriff.

If the "other parent" or "legal guardian" live in any other county or any other state, it will be your responsibility to contact that county or state and find out what their procedure and fees are for service.

### 3<sup>rd</sup> Party Service:

You can also have a friend (over the age of 18) or a private process server serve Form 3 & Form 4 on the "other parent" or "legal guardian". If this is the option you choose, ask the Family Law Clerk in Room 211 for a "3<sup>rd</sup> Party service packet" and follow the instructions in the packet.

### Certified Mail:

Use Certified Mail, Return Receipt Requested, to send Form 3 & Form 4 to the "other parent" or "legal guardian". This will only work if the "other parent" or "legal guardian" is willing to sign the return receipt. Attach the signed receipt (green card from the post office) to Form 11 (Proof of Mailing), fill out Form 11 and file it with the Family Law Clerk in Room 211. If the "other parent" or "legal guardian" will not sign the return receipt, you must arrange for personal service. If you use this method, you must add an additional three days to the thirty day posting period pursuant to ORCP 10 (c). This means you must schedule your hearing at least 33 days out instead of thirty days.

### Consent of "Other Parent" or "Legal Guardian"

If the "other parent" or "legal guardian" voluntarily agrees to the Name Change, the "other parent" or "legal guardian" can complete Form 10, have their signature notarized and return it for filing with the Family Law Clerk in Room 211. (If the "other parent" or "legal guardian" lives in Multnomah County, they can come to Room 211 and have the Family Law Clerk notarize their signature with proper identification)

### Waiver of Written Notice to Other Parent, pursuant to ORS 33.420 (3)

If the other parent has **NEVER** resided with the minor child and has never attempted to contribute to the financial support of that child, you may fill out Form 9 and have the Family Law Clerk in Room 211 notarized your signature. You must be a parent (as opposed to a legal guardian) in order to qualify to fill out Form 9.

#### (Second Visit to Courthouse-on the Hearing Date)

- STEP 5: A. Remove Form 4 (NOTICE OF NAME CHANGE HEARING) from bulletin board in Room 211.
  - B. Complete Form 5 (AFFIDAVIT OF POSTING NOTICE OF NAME CHANGE HEARING) and sign it in front of the Family Law Clerk in Room 211. Remember to bring proper identification with you, for this purpose.
  - C. Pay your \$10.00 judgment fee prior to going to the courtroom.
- A. Complete Form 6 (GENERAL JUDGMENT). Leave the following spaces blank: Judge's signature line and date. At the hearing, the Judge will decide whether to sign. **This form must be completed before you go to your hearing.** Take Forms 4,5 and 6 to the court hearing. The

### (Continued Instructions on Second Visit to Courthouse-on the Hearing Date)

Family Law Clerk in Room 211 will direct you to the appropriate courtroom. After your court hearing, the judge will keep Forms 4, 5 and 6 and instruct you to return to Room 211, as there is further processing that needs to be done.

- STEP 7: A. After your hearing, complete Form 7 (NOTICE OF GENERAL JUDGMENT OF NAME CHANGE).
  - B. Post Form 7 on small Name Change Bulletin Board in Room 211. (Board is clearly marked).
  - C. Fill out Form 8 (AFFIDAVIT OF POSTING NOTICE OF GENERAL JUDGMENT). Sign this in front of the Family Law Clerk in Room 211. Remember to bring proper valid photo identification with you for this purpose. The Family Law Clerk will keep Form 8 and file it with the court. IF YOU WISH MORE THAN ONE COPY OF YOUR GENERAL JUDGMENT, NOW WOULD BE THE TIME TO PAY THE COURT CASHIER FOR THEM. EACH CERTIFED COPY IS **\$5.00.**

### (After Leaving the Courthouse)

- D. A certified copy of your General Judgment will be mailed to you within two days of your hearing.
- E. Using the certified copy of your General Judgment as proof of the change, contact the Center for Health Statistics, P.O. Box 14050, Portland, OR 97239-0050, to change the minor's name on the birth certificate only if the child was born in Oregon. If your child was born in another state, you will need to contact that state to find out their requirements. The certified copy of the Judgment is needed for this purpose. - F. Contact other agencies to change the minor's name on other official records (Social Security, DMV – if applicable)
