#### INSTRUCTIONS

The application must be in the English language, typewritten or printed in black, legible and reproducible. See § 50-73.17 of the Code of Virginia. The document must be presented on uniformly white, opaque paper, free of visible watermarks and background logos.

The proposed name must be distinguishable upon the records of the Commission. See § 50-73.2 of the Code of Virginia. To check the availability of a limited partnership name, please contact the Clerk's Office Call Center at (804) 371-9733 or toll-free in Virginia at (866) 722-2551.

The name <u>must</u> contain the words <u>Limited Partnership</u> or <u>a Limited Partnership</u>, the abbreviation <u>L.P.</u> or the designation <u>LP</u>; provided, however, that if the limited partnership will also be applying for registered limited liability partnership status pursuant to § 50-73.132 of the Code of Virginia, the name <u>must</u> include either (1) (a) the words <u>limited partnership</u> or <u>a limited partnership</u>, or the abbreviation <u>L.P.</u> or <u>LP</u> and (b) the words <u>Registered Limited Liability Partnership</u> or <u>Limited Liability</u> <u>Partnership</u>, the abbreviation <u>R.L.L.P.</u> or <u>L.L.P.</u> or the designation <u>RLLP</u> or <u>LLP</u>, <u>or</u> (2) the words <u>Registered Limited Liability Limited Partnership</u>, the abbreviation <u>R.L.L.P.</u> or the designation <u>RLLP</u> or <u>LLP</u>, <u>or</u> (2) the words <u>Registered Limited Liability Limited Partnership</u>, the abbreviation <u>R.L.L.P.</u> or the designation <u>RLLP</u>. See § 50-73.2 of the Code of Virginia.

## The "applicant" is the individual or entity that is the sole holder of the reserved name.

A reserved name may be renewed only by or on behalf of the applicant who holds the reserved name.

The owner of a reserved limited partnership name may renew the reservation for successive periods of 120 days each by filing with the Commission, during the 45-day period preceding the date of expiration of the reservation, a renewal application. See § 50-73.3 of the Code of Virginia.

Submit the original, signed application to the Clerk of the State Corporation Commission, P.O. Box 1197, Richmond, Virginia 23218-1197, (Street address: 1300 East Main Street, Tyler Building, 1<sup>st</sup> Floor, Richmond, Virginia 23219), along with a check for the filing fee in the amount of **\$10.00**, payable to the State Corporation Commission. **PLEASE DO NOT SEND CASH**. ## NOTE

A **transfer** of a reserved name may be accomplished by submitting to the Clerk's Office a written notice that sets forth the reserved name and the name and address of the person to whom the name is to be transferred, accompanied by a check in the amount of \$10.00 made payable to the State Corporation Commission. The notice must be signed by the applicant that holds the reserved name or by the applicant's authorized agent.
