App. 1 Cir. 9/7/05), 923 So. 2d 81, *writ denied*, 05-2372 (La. 3/17/06), *cert. denied*, 549 U.S. 822, 127 S. Ct. 157, 166 L. Ed. 2d 38 (2006), be and hereby are stayed pending further orders of this court.
